# TEMPORARY ADVERTISEMENT FOR VERTICAL BANNER / HORIZONTAL BANNER / GIANT BANNER

## Licensing Terms and Conditions

**INTERPRETATION:**

TEMPORARY LICENCE / ADVERTISEMENT as classified under **By-Laws 9, The Local Authorities (Advertisement) By-Laws, 2012;** purpose are for announcing local evens, information or notification of product, activities or services only.

Types and sizes of the advertisement are as follows :-

Vertical Banner; Banting/Fishtail/Streamer [shall not exceed 2m (height) x 0.74m (width)]

Horizontal Banner; [shall not exceed 1.22m (height) x 6m (width)]

Giant Banner (any size that exceeding the size of the Horizontal Banner)

**LICENSING TERMS AND CONDITIONS:**

1.	All advertisement exhibited within Sarikei District Council must be licensed and approval is on monthly basis ;
2.	Words and letters in <b>Bahasa Malaysia</b> when used together with any other language must be given prominence in term of size and colour, and in more outstanding place than words or characters in the other language used ;
3.	Advertisement displayed on Private properties must be consented by the owner. <b>FOR OWNER CONSENT in FORM A (APPLICATION FOR ADVERTISEMENT LICENCE)</b> must be dully signed ;
4.	The advertisement shall be displayed for a period of <b>NOT</b> more than Three (3) consecutive months, except advertisement on <b>EVENTS</b> , the licence shall <b>EXPIRED</b> concurrently with the closing of events ;
5.	Licence issued shall not be <b>transferable</b> or <b>assignable</b> . Licence Number must be clearly shown at the <b>bottom right hand corner</b> of the advertisement with the size of not less than 0.10m (height) x 0.46m (width) ;
6.	Advertisement shall not only be displayed accordingly to the sample presented upon application and at the approval site(s) ;
7.	All advertisement must be removed within the <b>two days</b> after the expiry of the licence ;
8.	All content and visual must be <b>non-offensive</b> in nature ; Obscenity, seductive, act of violence and any other sensitive issues on religion, races, language and politics, political logos and slogan are prohibited ;
9.	Advertisement on any tobacco products, liquor and illicit drugs are prohibited ;
10.	The advertisements displayed shall not caused any obstruction to the public, road, building or nature; light, ventilation, access to the building, windows, fume exhaust placed on the outer wall of the building, road signage, and etc ;
11.	Advertisement must be securely fastened and must be maintained in good state at all time ;
12.	Constructions of any structure(s) for the advertisement's on Public Places are strictly prohibited ;
13.	No advertisement shall be allowed on any vegetation ;
14.	Displaying of advertisement at / within the traffic round-about and across any road / street are prohibited are prohibited ;
15.	Advertisement shall not be displayed less than five (5) meters away from the traffic light / road junction ;
16.	The lowest part of the advertisement must be hung above 2 meters from the ground; road / pedestrian path / road divider / traffic island and etc. (whichever higher) ;
17.	On the lamp posts, two tiers advertisement are prohibited, back to back are accepted except for State flag, Jalur Gemilang and government related matters ;
18.	Licence issued for displaying at protocol roads are subjected to revocation when need arises. The licence fee paid shall not be refunded except the same number of days shall be replaced upon reactivated ;
19.	The Sarikei District Council shall not held responsible for any accident or mishap that may occur arising from the advertisement ;
